You and your Co-Exhibitor(s) will have the opportunity to easily create and submit your information through our Online Exhibitor Directory.

SEMICON Exhibitor Portal (MMA)

To access, please log in to your [Exhibitor Portal](#). The username and password are the same that you used to create your MMA account during application.

Here are some tips to get the most value out of your exhibitor manual:

1. Read through the guidelines which contains General Information, Operations Schedule, Technical & Safety Regulations and Onsite Handling Tariff.
2. Ensure order forms are submitted by the **deadline (01 August)** to avoid surcharge. Orders placed after the deadline will incur additional charges and are subject to availability.
3. Submit by 01 August 2024
 - Registration of Exhibitor Badges
 - Fascia Name (for *Shell Scheme* booth exhibitors)
 - Booth Design and Plan Approval (for *Bare Space* booth exhibitors)
 - **Indoor Heavy Machinery**
4. Bare space booth exhibitors are requested to submit for APPROVAL on their booth layout plan, elevation with dimensions, 3D artists impression and electrical single line drawing within the deadline mentioned. Refer to OEM Guidelines page 10 under **BOOTH/STAND DESIGN SUBMISSION** for more information.
